

A child turning 3 between Jan and Mar is eligible from the following Apr.	Both parents must earn more than 16 hours x minimum wage per week and less than £100,000pa.
A child turning 3 between Apr and Aug is eligible from the following Sep.	30 Hours must be sought in order to enable work.
A child turning 3 between Sep and Dec is eligible from the following Jan.	One parent can meet the earnings criteria if the other is unable to work due to disability, caring responsibilities or assessed limited capability to work.
30 Hours only sessions run 8am to 6pm where available. A subsidy of £20 per day is payable to cover all meals, classes, trips and other extras.	Newly self employed parents do not need to prove earnings in first 12 months (start-up period).
30 hours only sessions only run 38 weeks per year. You risk losing your place if you do not pay the extra session rate outside of term dates.	If one or either parent is a non-EEA national they must have recourse to public funds.
